The United Kingdom of Great Britain and Northern Ireland (UK) consists of a group of islands off the western coast of Europe. The largest, Great Britain, comprises three countries: England, Scotland and Wales. Ireland, to the west, consists of the UK's province of Northern Ireland and the Irish Republic. There are several offshore islands and island groups, the largest lying off Scotland.

The UK is a union of four countries: England, Scotland, Wales and Northern Ireland. The Crown dependencies (the Channel Islands and the Isle of Man) are largely self-governing with the UK responsible for their defence and international relations and are not part of the United Kingdom.

UK VISIT VISA

United Kingdom : Tourist Visa

You can go to the UK as a Standard Visitor:

- for tourism, for example on a holiday or to see your family and friends
- for certain business activities, for example attending a meeting
- to do a short course of study
- to take part in research or an exchange programme as an academic
- for medical reasons, for example to receive private medical treatment

What you can and cannot do:

You can:

- visit the UK to do certain activities, for example visiting friends and family or attending a conference.

You cannot:

- do paid or unpaid work for a UK company or as a self-employed person
- live in the UK for long periods of time through frequent visits
- claim public funds (benefits)
- do a course of study that lasts longer than 6 months
- marry or register a civil partnership, or give notice of marriage or civil partnership. You'll need a Marriage Visitor visa instead

UNITED KINGDOM

GLOBAL TALENT VISA

Overview

You can apply for a Global Talent visa to work in the UK if you're a leader or potential leader in one of the following fields:

- academia or research - science | medicine | engineering | humanities
- arts and culture- combined arts | dance | literature | music | theatre or visual arts | architecture | fashion design | film and television, including animation, post production and visual effects
- digital technology - financial technology ('fintech') | gaming | cyber security | artificial intelligence

You must also be at least 18 years old.

Before you apply for a visa

You can only apply for a Global Talent visa once you have successfully applied for an endorsement to prove that you are a leader or potential leader.

How long you can stay

You can live and work in the UK for up to 5 years at a time.

If you want to stay longer in the UK

There's no limit to how long you can stay in the UK in total, but you will need to renew ('extend') your visa when it expires. Each extension can last from 1 to 5 years.

You may be able to get indefinite leave to remain so you can settle in the UK after 3 or 5 years, depending on the endorsement path you are applying for. This gives you the right to live, work and study here for as long as you like, and apply for benefits if you're eligible.

Getting a decision

Once you've applied online, proved your identity and provided your documents, you'll usually get a decision on your visa within:

- 3 weeks, if you're outside the UK
- 8 weeks, if you're inside the UK

STARTUP VISA

Overview

You can apply for a Start-up visa if:

- you want to set up an innovative business in the UK - it must be something that's different from anything else on the market
- you meet the other eligibility requirements

Eligibility

You must be endorsed by an authorised body that is either:

- a UK higher education institution
- a business organisation with a history of supporting UK entrepreneurs

You must be able to show that your business idea is:

- a new idea - you cannot join in a business that is already trading
- innovative - you must have an original business idea which is different from anything else on the market
- viable - it has potential for growth

What you can and cannot do

With a Start-up visa you can:

- work in another job, as well as working for your business
- travel abroad and return to the UK
- bring your partner and children with you as your 'dependants', if they're eligible

You can also switch to this visa from some other visa categories.

You cannot:

- apply for most benefits (public funds), or the State Pension
- work as a professional sportsperson, for example a sports coach
- settle in the UK on this visa

How long you can stay

You can stay for 2 years if you either:

- come to the UK on a Start-up visa
- switch to this visa from another visa while in the UK

UNITED KINGDOM

INNOVATOR VISA

Overview

You can apply for an Innovator visa if:

- you want to set up or run a business in the UK
- you're from outside the European Economic Area (EEA) and Switzerland
- you meet the other eligibility requirements
- your business or business idea has been endorsed by an approved body

Funds you'll need

You must have at least £50,000 in investment funds if you want to set up a new business. You do not need funds if either:

- your business is already established and has been endorsed for an earlier visa
- you've changed your business and already agreed it with your endorsing body

Getting endorsed

You must be able to show that your business idea is:

- new - you cannot join or invest in a business that is already trading
- innovative - you must have an original business idea which is different from anything else on the market
- viable, with potential for growth

you should only approach ones that are suitable for your business idea.

How long it takes to get a visa

The earliest you can apply is 3 months before you travel. You should get a decision on your visa within 3 weeks when you apply from outside the UK.

How long you can stay

You can stay for 3 years if you:

- come to the UK on an Innovator visa
- switch to this visa from another visa

You can apply to extend for another 3 years when your visa is due to expire. There's no limit on the number of times you can extend. You may be able to apply for settlement (known as 'indefinite leave to remain') once you've been in the UK for 3 years.

INNOVATOR VISA

What you can and cannot do

You can:

- set up a business or several businesses
- work for your business - this includes being employed as a director, or self-employed as a member of a business partnership
- bring family members with you

You cannot:

- do any work outside your business, for example work where you're employed by another business
- work as a doctor or dentist in training
- work as a professional sports person, for example a sports coach
- get public funds

Eligibility

Before you apply you need to have your business or business idea assessed by an approved body. They will provide you with an endorsement letter if your business is viable.

You must also:

- meet the English language requirement
- be at least 18 years old
- be able to prove that you have enough personal savings to support yourself while you're in the UK

Documents you must provide

- When you apply you need to provide an 'endorsement letter' to show that an approved body has assessed your business or business idea.
- a current passport or other valid travel identification
- bank statements showing you've had at least £945 in savings in your bank account for 90 consecutive days before you apply
- proof that you meet the English language requirement
- evidence of your investment funds (if you're setting up a new business)
- your tuberculosis test results if you're from a country where you have to take the test
- You need a blank page in your passport for your visa.
- You'll need to provide a certified translation of any documents that are not in English or Welsh.

You may need to provide additional documents depending on your circumstances.
